Dear Residents of FSK, JJ, and Potomac Halls:

With the fall semester starting this week, we want to provide you with an update on construction of the Law Learning Center Garage just north of your residence hall in the 2000 block of G Street. As you can imagine, residents living near this site will experience some noise and other inconveniences as a result of this construction activity – *especially during excavation activities that will continue this fall*. We apologize in advance for disturbances and are working with our contractors to minimize (to the extent possible) the impact to neighboring buildings. Also, we realize that creating a world-class campus requires all of us to be patient during campus development.

All demolition and construction work will occur during hours permitted by the District of Columbia for construction: *Monday to Saturday, between 7am-7pm*, except in special/pre-approved circumstances (which will be announced to surrounding residence halls when possible) and/or emergency situations. We are also working with the contractors to schedule, to the extent possible, especially noisy work to begin later in the morning. Our goal is to start such exceptionally noisy activities after 8 a.m. on weekdays and after 9:00 am on Saturdays. To be clear, work will occur on site beginning at 7:00 am, but we are making our best effort to delay the start of some noisy construction activities.

To clarify, “exceptionally noisy” activities are defined as: surface scraping and asphalt/concrete demolition; jack hammering; driving of piles/use of hoe ram; repeated/continuous honking/idling in vicinity of residence halls, and; loud/boisterous outdoor conversations within close proximity to residence halls.

The university provides free ear plugs to any student who requests them as well as white machines that can be loaned for the school year. There are also several free white noise options that you can run on your computers or smart phones, here’s one we found: <http://itunes.apple.com/us/app/white-noise-lite/id292987597?mt=8>. Thank you, in advance, for your patience. Your cooperation will greatly contribute to the success of this endeavor and will help enhance GW’s prestige as a world-class research university. We will continue to update you throughout the fall on this project’s progress, and will hold several informational sessions in your residence hall lobby early in the semester that will be advertised in advance.
