Community members can apply in person at the GWorld Card Office (800 21st St NW, G05) with a valid **D.C.- issued Driver License** or **D.C.-Issued ID Card**.

Residents who do not have a D.C.- issued Driver's License or D.C.-Issued ID Card can submit a utility (electric, gas, water, cable) bill, no more than 1 month old, as proof of residency through our online authorization portal.

Once the application is received and reviewed, OGCR will notify applicants via email. Approved community members can then visit the GWorld office to pay, take their photo, and pick up their Friends of GW Card. Cards. Community members must bring a state-issued ID for verification at the time of the card pick-up.

I St Mall Updates:

- Feedback Received:
 - Need for security
 - Enhanced lighting
 - Plantings
 - Reduce rodents
 - Better trash cans
- Key Design Elements:
 - Elimination of rat burrowing areas
 - Treatment of soils to prevent future burrowing
 - Removal of central planting berms to increase safety/visibility across the plaza
 - Increased lighting for safety and visibility
 - Increased tables and chairs for gathering and community engagement
 - Additional trash and recycling receptacles, including "Bigbelly" models which are larger and less accessible to pests
- Status:
 - Pending funding and permit. Expected Summer 2024 project.
