#### **Friends of GW GWorld Card Program**

Community members can apply in person at the GWorld Card Office (800 21st St NW, G05) with a valid **D.C.- issued Driver License** or **D.C.-Issued ID Card**.

Residents who do not have a D.C.- issued Driver's License or D.C.-Issued ID Card can submit a utility (electric, gas, water, cable) bill, no more than 1 month old, as proof of residency through our online authorization portal.

Once the application is received and reviewed, OGCR will notify applicants via email. Approved community members can then visit the GWorld office to pay, take their photo, and pick up their Friends of GW Card. Cards. Community members must bring a state-issued ID for verification at the time of the card pick-up.
