Dear Ms. Schellin:

On behalf of the University, enclosed please find an application for second-stage approval of a Planned Unit Development ("PUD") for the above-referenced Property. The Property is one of sixteen development sites identified in the University's first-stage PUD for its Foggy Bottom Campus. In addition, the University, on behalf of Educational Foundation for Gamma Eta, also requests modification of the first-stage PUD in order to incorporate Lot 18, which was not included in the first-stage PUD in 2006. The University is now under contract to purchase the lot. Finally, the University concurrently requests further processing approval for the proposed application under its approved Foggy Bottom Campus Plan.

The application packages enclosed herein meet the filing requirements detailed in Section 2406 of the Zoning Regulations, and include the completed application forms, copy of the notice of intent to file the PUD that was mailed to surrounding property owners and parties (with certification of mailing and list of property owners), and detailed architectural drawings, plans, and elevations of the proposed project (which include a map depicting the Zone Districts for the property and surrounding area). Also included are the materials that the University is required to file with each second-stage PUD application.

Attached to this letter are letters of authorization from the University and Educational Foundation for Gamma Eta, preprinted labels for the surrounding property owners and parties, and a check for \$3,400, which represents the filing fee in this matter.
