Final Conditions of Approval

Dear Chairman Hood and Members of the Commission:

In response to comments received from the Office of the Attorney General, the University has revised and updated its final conditions of approval. The final conditions of approval for each proffered benefit are provided below. New language added or modified in response to OAG's comments is <u>underlined</u>.

Please note the following regarding Condition 9(b) regarding the selection of an alternative school for the fellowship position. Condition 9(b) reads:

In the event that the Francis-Stevens Education Campus is no longer in operation, the University shall work with ANC 2A to select another D.C. public school <u>that serves ANC 2A</u> for the fellowship position or instructional/counseling position.

The underlined language was incorporated at the request of ANC 2A. Given the lack of public schools within the boundaries of the ANC (indeed, Francis-Stevens, the public school that serves preschool through eighth grade students that reside within ANC 2A, is located immediately outside of the ANC's boundaries), the ANC felt it was important to provide flexibility for the benefit to be used for a school that serves ANC 2A's population, even if the school itself is not necessarily located within the boundaries of ANC 2A. The condition complies with Section 2403.13 of the Zoning Regulations, because the public benefit (the educational position) accrues directly to the residents of ANC 2A.

We look forward to the Zoning Commission taking Final Action on this case.

If, prior to January 1, 2015, the Village has not yet entered into the lease, the University shall be permitted to return to the Zoning Commission to identify a substitute public benefit.

If requested in writing by the Village, the Village may allocate up to \$15,000 of the above \$100,000 contribution to expenses incurred by the Village in outfitting the office space and the University shall reimburse the Village for such reasonably documented expenses. Such expenses may include costs associated with adding computer lines, cable upgrades, or other improvements that would be considered an additional cost for the initial set up of office space for use by the Village. The University will approve and reimburse the Village for such reimbursable expenses within thirty days after the date they are submitted. Any amount reimbursed pursuant to this section shall be deducted from the

In the event that the University is unable to establish the fellowship position, the University shall contribute \$50,000 to the Francis-Stevens Parent Teacher Association to fund the establishment of an instructional or counseling position to be determined by the Francis-Stevens Parent Teacher Association that will support educational programs at Francis—Stevens Education Campus.
- b. In the event that the Francis-Stevens Education Campus is no longer in operation, the University shall work with ANC 2A to select another D.C. public school that serves ANC 2A for the fellowship position or instructional/counseling position.
