The George Washington University ("University") 2007 Foggy Bottom Campus Plan First Stage PUD ("First Stage PUD") Minor Modification of the First Stage PUD

Dear Chairman Hood and Members of the Commission:

As detailed in the related application for amendment of the 2007 Foggy Bottom Campus Plan ("Campus Plan"), filed concurrently with this request, the University has acquired three townhouses within the boundaries of the campus that it intends to use for university-related purposes. These properties were acquired subsequent to the approval of the Campus Plan and related First Stage PUD.

Since the properties discussed above are not part of the development sites designated under the Campus Plan / PUD, no modification of the First Stage PUD is technically required. In order to ensure that the Campus Plan and First Stage PUD remain consistent, however, the University requests that the Commission also approve the above use designations as a minor modification of the First Stage PUD. The proposed changes are minor for the reasons stated in the Campus Plan amendment—the uses are consistent with the use designations of adjacent properties and will provide needed space on campus, consistent with the goals of the Campus Plan / PUD. Furthermore, the University's ability to develop these properties is limited by the approved conditions of the Campus Plan / PUD.

The decision on this minor modification could be reserved until after the hearing on the amendment filed concurrently with this request, and made at the same time as the decision and vote on that campus plan amendment.

Enclosed please find the application form and a check for \$520.00 representing the filing fee in this matter as well as a list of all property owners within 200 feet of the properties that are
